Registration:

- General Entry Registration:
 - General entries—including day-of—will be accepted, as space is available after pre-entry deadlines have passed.
 - Fees: \$40.00 per handler for the 1st dog, \$15 for 2nd dog, \$10 each add. dog.

Details:

- Limit of 40 dogs. Typically 4 – 6 runs, as time permits.
- The matches are to provide handlers and dogs with an opportunity to practice in an environment that simulates a trial. It is not for competition. Dogs and handlers must have some agility experience and be able to use the equipment safely off leash. Jump heights are at your discretion. Treats and toys in the ring are *encouraged*.
- Two rings will run simultaneously: one Standard and one Jumpers, each offering hybrid Open/Excellent and Novice/Open level courses. One ring will run small to tall and the other tall to small.
- There will be a ninety second maximum time in the ring for each run. Running orders will be established the morning of the match. Please only run once during your jump height; jump heights will be rotated through again for additional runs.
- Shade is somewhat limited; participants are encouraged to bring canopies, umbrellas, crates etc.
